## Earnings & age

Earnings increase directly in line with age, up to age xx. On average, architects in their forties earn xx per cent more than their younger colleagues in their thirties; and architects in their fifties earn xx per cent more than those in their forties.

The chart (left) shows how the earnings of particular cohorts of architects have changed over time. This shows what an architect aged 35, 45, 55 and 65 in 2009 would have earned on average over the past twenty years of his or her career. Although

earnings generally increase in line with age since 1987, those who are now aged xx would have consistently earned more than those who are now xx. And the differential between those now aged xx and xx has been reduced to nil for much of the period since 2001.

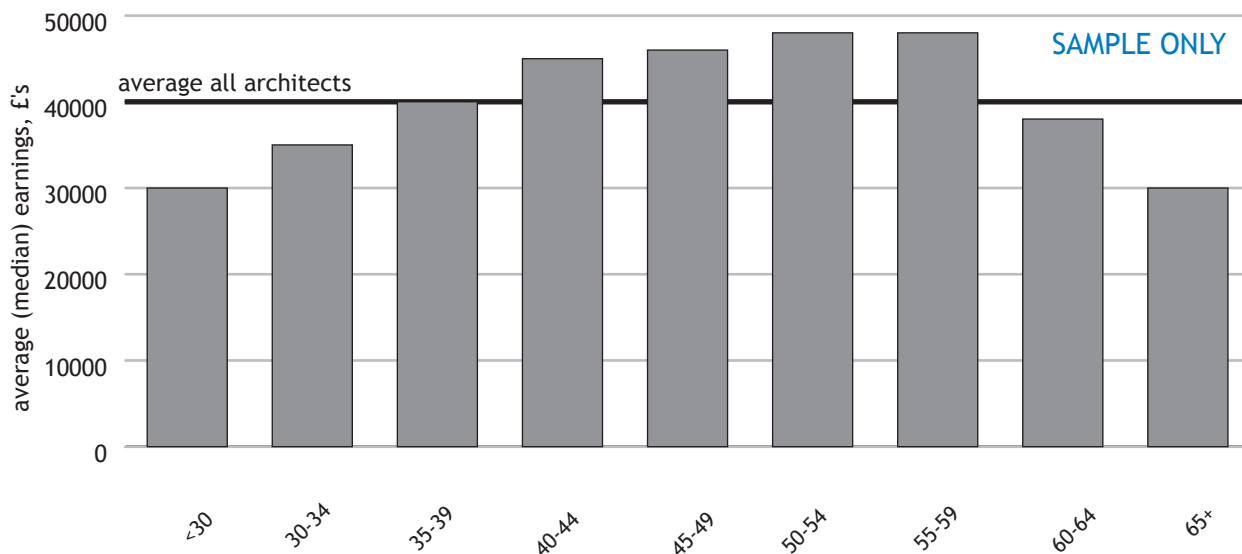
Average earnings for those now aged xx and xx have turned down; while earnings for architects now aged xx continue to rise.

Median earnings of Salaried Architects by size of practice, 2009

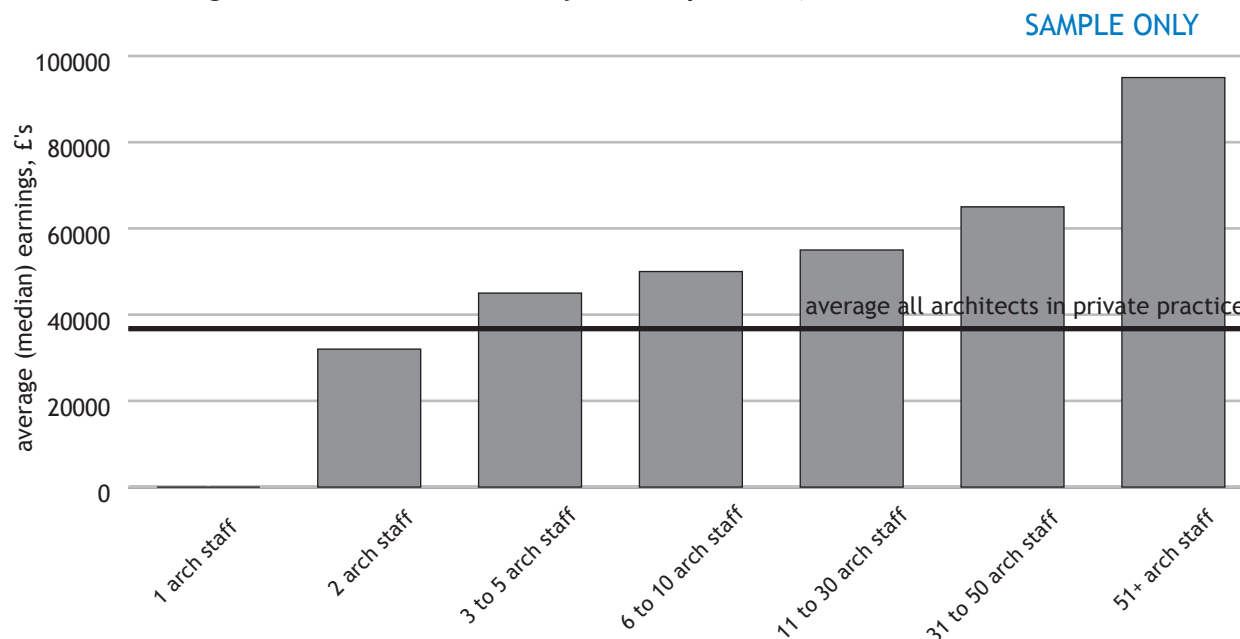

## Fringe benefits received

Topping the list of fringe benefits for architects are subscription to the RIBA and ARB (received by xx and xx per cent respectively). xx per cent receive a contributory pension, and xx per cent a non-contributory pension - implying that xx per cent receive no pension benefit at all. Public sector architects are more likely to receive a contributory pension; just xx per cent of Sole Principals receive a pension.

A company car is provided to xx per cent of architects, another xx per cent receive a mileage allowance. Highest company car provision is amongst private in-house architects (xx per cent). Rather more architects receive private medical insurance (xx per cent) than life insurance (xx per cent). Private in-house architects record the highest average benefit values of company cars while the highest value of non-contributory pensions goes to Principals in Partnership.

Per cent of Sole Principals receiving benefits

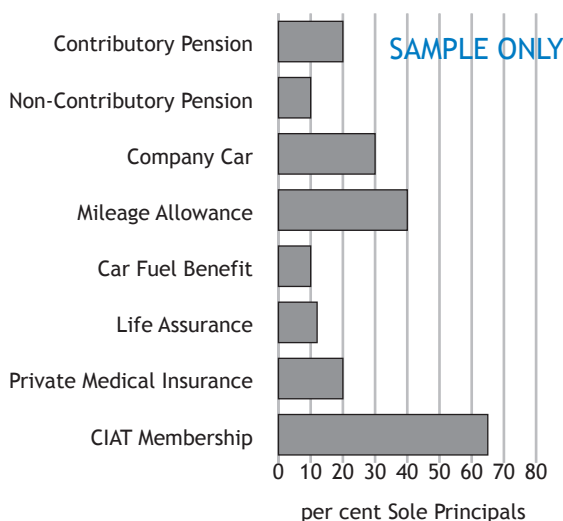
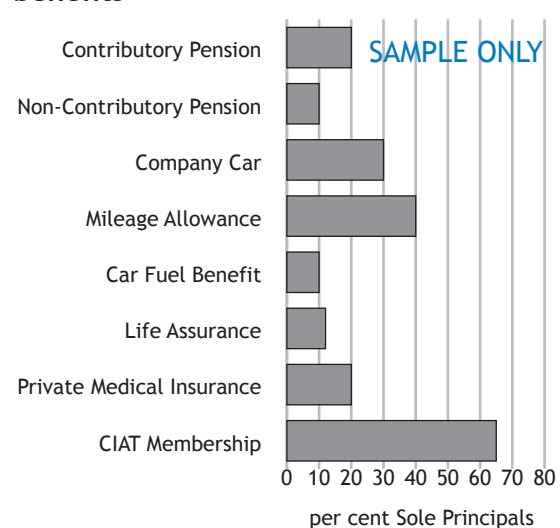


CHART 5-7

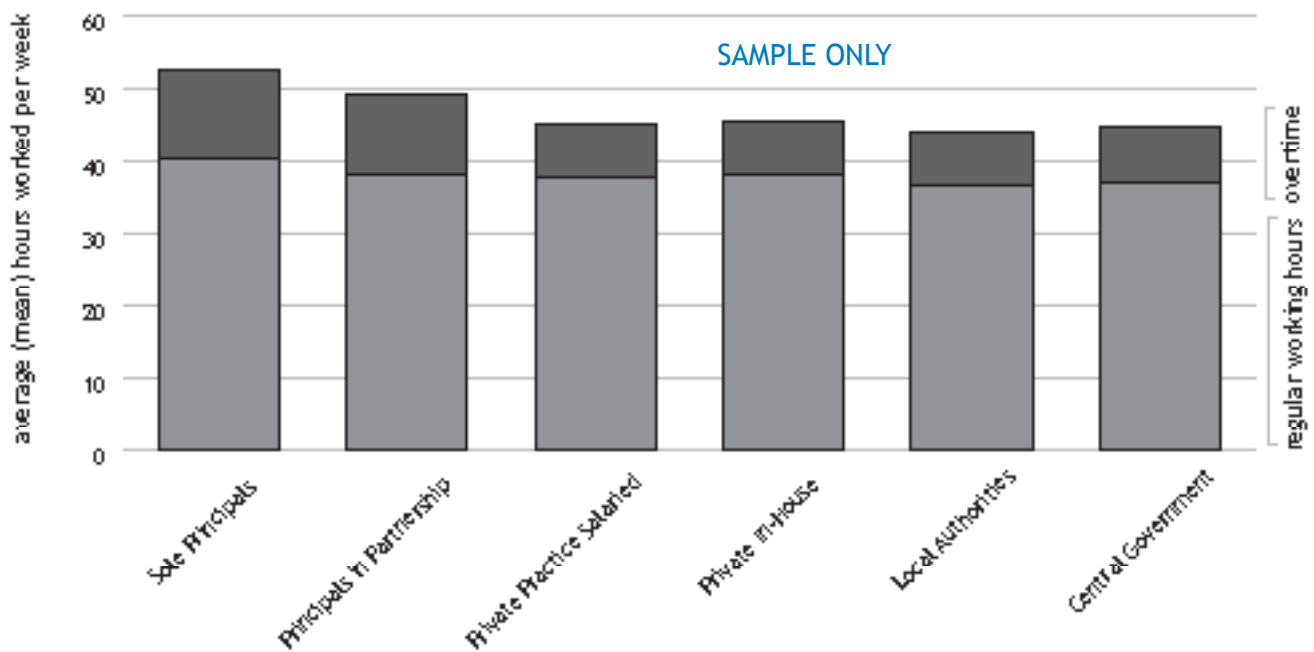
